- The quotation/tender must be in the form furnished by the Purchaser/as per tender specifications and should be free from corrections/erasures. - (a) Where there is no mention of packing, forwarding, freight, insurance changes, taxes etc. <u>such offer shall be rejected as</u> incomplete. As such clearly mention these charges.
- (b) The bidder should give a clear cut break up of ex-works, FOB/FCA, CIF/CIP price to facilitate the proper comparison <u>failing which the bid would be summarily ignored/rejected</u>.
