With reference to above, this is to inform you that CSIR-Central Scientific Instruments Organisation (CSIO), Chandigarh is a constituent unit of Council of Scientific & Industrial Research (CSIR), under the Department of Scientific & Industrial Research, Government of India is a premier National laboratory. As per Pharmaceuticals Purchase Policy, 2013 notified by Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers vide OM 50(9)/2010-PI-IV Dated 10/12/2013, this laboratory needs to procure medicines as per list attached for CSIO Clinical Centre, Sector 30C, Chandigarh as per terms & conditions:
