This office notified names of shortlisted candidates for written examination for the post of Assistant Grade III (G) [now redesignated as Junior Secretariat Assistant (G)] on 11.04.2018 and thereafter **some of the candidates sent emails to CSIR-CSIO related to rejection of their candidature**, enclosing relevant documents in support of their claim. The same were considered by duly constituted screening committee and its recommendations duly approved by Director, CSIR-CSIO are as under:-

2.	76506	Namrata Singh	Late receipt	Requested for reconsideration as the application was received late through post.	The Committee considered the request and recommended that since the hard copy of application of the candidate reached CSIR-CSIO after the last date of submission of hard copy by post i.e. 13.11.2017, the request regarding consideration of her application is not admissible as candidates were already informed in the advertisement vide clauses 4(i) & 4(m). Therefore, the candidature remains rejected.
3.	79463	Amit Sharma	Over age	Requested to grant him age relaxation being resident of J&K	The document of residency produced by the candidate does not mention the period of residency in the State of J&K. Also, no reply of CSIR-CSIO e-mail dated 11.05.2018 has been

					received from the candidate till date. Therefore, the Committee recommended that his request may not be acceded to as he could not produce any document complying with the requirement of advertisement, <i>to submit a certificate from the District Magistrate within whose jurisdiction he had originally resided in the State of J&K during the period from 1.1.1980 to 31.12.1989 or from any other authority designated in this behalf by the Govt. of J&K as required under the rules and advertisement [clause 3(f)].</i> Therefore, the candidature remains rejected.
4.	75789	Mandeep Singh	Over age	Requested to grant him age relaxation being resident of J&K during the period <i>from 1.1.1980 to 31.12.1989</i>	Domicile Certificate of J&K produced by the candidate states that the candidate has been continuously residing in J&K (any time during the period) w.e.f. January, 1980 to December, 1989. He has been found eligible for age relaxation of 5 years and his name has been included in the list of recommended candidates. Therefore, the candidature has been accepted.
