Result of Screening Process to shortlist the candidates for Skill test/trade test against recruitment of one post (01)(UR) of Driver (Isolated Non-Tech.) Group 'C' (Advt. No. 05/2019)

One post of (01-UR) of Driver was advertised vide Advertisement No. 05/2019. Total 53 no. of applications were received online within stipulated time period i.e. by 21.12.2019 (only online applications invited). The minimum eligibility criteria as per advertisement is as under:-

- Essential Qualification:-** (i) Possession of a valid driving license for LMV & HMV.
(ii) Knowledge of motor mechanism (The candidate should be able to remove minor defects in vehicle)
(iii) Experience of driving a motor car for at least 3 years; and,
(iv) Pass in 10th Standard.

Desirable Qualification :- The candidate should be well versed with the topography and road routes of Delhi & Chandigarh.

Age Limit:- 18 to 27 years as on last date of submission of online application i.e. 21.12.2019 with relaxation to eligible candidates as per advertisement (Ex-Serviceman etc.). The post is UR. No age relaxation admissible to other categories.

P-1*:-Subject to compulsory production of evidence to the claim of having 10th Pass certificate at the time of trade/ Skill test /written examination or before, failing which his/her candidature shall not be considered further and will not be allowed to appear in written examination/ trade/ Skill test. (refer to essential qualification and clause 5'd' of the advertisement)

P-2*:- Subject to production of caste certificate (if any relaxation/Concession is claimed) at the time of written examination/ trade/ Skill test or before, failing which his/her candidature shall not be considered further and will not be allowed to appear for trade/ Skill test /written examination (refer clause 2 'e' & 5-f 'i' of the advertisement).

P-3*:-Subject to production of documentary evidence for the age, as claimed in application form. (as per advertisement)

P-4* :-Subject to production of documentary evidence of having a valid driving licence for LMV & HMV as on 21.12.2019 as claimed in application form. (as per advertisement)

P-5* :-Subject to production of documentary evidence of having a Ex- Serviceman Service Certificate as claimed in application form.

P-6* :-Subject to production of documentary evidence of having a Experience Certificate as claimed in application form. (as per advertisement)

The candidates who have been allowed to appear for trade/ Skill test/ written examination subject to production of documents/certificates as mentioned under 'Remarks' column (with remarks P1, P2, P3, P4 & P5, P6.b) against their names are to be advised to ensure that they must produce these documents/certificates on or before the day of trade test/written examination, failing which they will not be allowed to appear for the written examination/ trade test and their candidature will be cancelled without any further notice.
